On Completion of 01st Floor Roof Slab	7.5% of Basic Sale price + 50% of Car Parking
On Completion of 4th Floor Roof Slab	7.5% of Basic Sale price + 50% of EDC & IDC
On Completion of 8th Floor Roof Slab	7.5% of Basic Sale price + 50% of EDC & IDC
On Completion of 12th Floor Roof Slab	7.5% of Basic Sale price
On Completion of 16th Floor Roof Slab	7.5% of Basic Sale price
On Completion of Structure	5% of Basic Sale price + 50% of PLC
On Completion of Brick Work	5% of Basic Sale price + 50% of PLC
On Completion of Electrical Conduiting	5% of Basic Sale Price
On Completion of Flooring	5% of Basic Sale Price
On Notice of Possession	5% of Basic Sale Price + Club Charges + IFMS + Registration and Stamp Duty Charges, as applicable

(C) DOWN PAYMENT PLAN (DPP)	
On Booking	20% of Basic Sale Price
Within 60 Days of Booking	75% of Basic Sale Price + 100% of Car Parking Charges + 100% PLC
On Notice of Possession	5% of Basic Sale Price + EDC + IDC + IFMS + Club Membership + Registration and Stamp Duty Charges, as applicable
