Application Procedure

2. Payment Schedule should be attached with the Application Form and shall be duly signed by the Applicant/Applicants as well as the Co-applicants thereto.
3. This application is only a request of the applicant(s) for allotment of unit (s) subject to the payment of the entire sale value of the said flat/apartment/unit etc by the Applicant/applicants therein in favour of ----- and moreover this application does not create any right or title whatsoever or howsoever of the applicant on the said property.
4. The applicant (s) do hereby agree(s) to abide by to pay the consideration money and the extra charges as applicable hereto and as per the agreed payment schedule.
5. After provisional allotment the purchaser should complete the procedure of Sale Agreement within 25 days as per the English Calendar from the date of booking. Non compliance of the same will attract penalty as decided by the management from time to time and as per the policy therein to be dealt with in case of non-compliance by the customers/applicants/co-applicants respectively.

Cancellation Procedure

- 1 At the event of Cancellation before the execution of Agreement for sale, 25% of the *booking amount along with a specific deduction of taxes as applicable thereto will be deducted from the payments made and balance will be refunded within more or less 45 official working days from the date of cancellation.

- 2 At the event of Cancellation after execution of agreement for sale 25% of total payment will be deducted alongwith a deduction of specific taxes as applicable thereto, from the payments made and balance will be refunded within more or less 45 official working days from the date of cancellation.
- 3 That if the customer intend to cancel and cancelled duly the booking within 7days from date of booking *vis-à-vis* provisional allotment in that case all the money will be refunded within a period of more or less 30 official working days from the cancellation date.
- 4 Cancellation amount will be paid by cheque only.
